Student Presentation on School Store - Students Cody Fox and Caleb Bashore provided a presentation on the possibility of opening a school store through the Transitions Classroom. Students would sell P-W products to the staff, students and community while gaining valuable experience in communications, cleaning, inventory management, money management, design, task following and other skills. Two items needed to purchase include a screen printing machine and a cash register. Hoping to use donations to purchase the start-up items. Shirts, mugs, water bottles and hats are some of the items the students would like to sell. Funds gained could be used for ordering more supplies, funding classroom outings as well as outings with LINKs. Treasure Island is the suggested name for the store. Students visited school stores in DeWitt and Grand Ledge, where their finance class students assist with bookkeeping services.

Administrator's Reports:

Instructional Technology Specialist: Stacey Johnston reported the P-SAT test was given using technology last week. At a previous meeting, Mr. Hafner requested information on cyber security; S. Johnston is still seeking that information.

Assistant Principal/Athletic Director: Ryan Portenga recognized the high school band for their Division I ratings. The performance of the theater students last week was excellent. The football team, cross country and volleyball teams are peaking at the perfect time.

Middle/High School Principal: Ryan Portenga expressed his appreciation of Larry Farmer for his outstanding efforts for the standardized testing last week. The Middle/High School staff spent time during professional development last week to identify inefficiencies and use those to guide us in future planning. The need for vertical alignment with the parochial schools is apparent and we plan to have a joint meeting within the school year.

Elementary School Principal: Julie Farmer welcomed everyone to the portable classroom (where this meeting is being held) and thanked everyone for their efforts to ensure a smooth transition to this new building.
